## Key Benefits

- Member to member liability extended to include guests of members
- Loss of revenue resulting from denial of access, bomb hoax, unlawful occupation, loss of attraction, notifiable disease and legionella
- Employers' Liability £10,000,000
- Public and Products Liability £5,000,000
- Reimbursement of membership subscriptions up to £10,000
- Theft by employees up to £25,000
- Legal defence costs arising from prosecution under the Corporate Manslaughter and Corporate Homicide Act 2007
- Cover for greens, fairways, tees, trees and plants including accidental damage by greenkeepers up to £100,000
- Cancellation or abandonment of events up to £10,000
- Public Liability cover extended to include unlicensed vehicles such as buggies within the boundaries of the Club or roads immediately adjacent to it
- Damage to ground maintenance equipment in the open up to £25,000

## Optional Covers

- Personal possessions of club members up to £1,500 per member
- Wedding cancellation costs
- Public Liability cover extended to include Beauty Treatments
- Terrorism cover for property damage and business interruption
- Personal accident cover for Officers, committee members and employees up to £20,000
